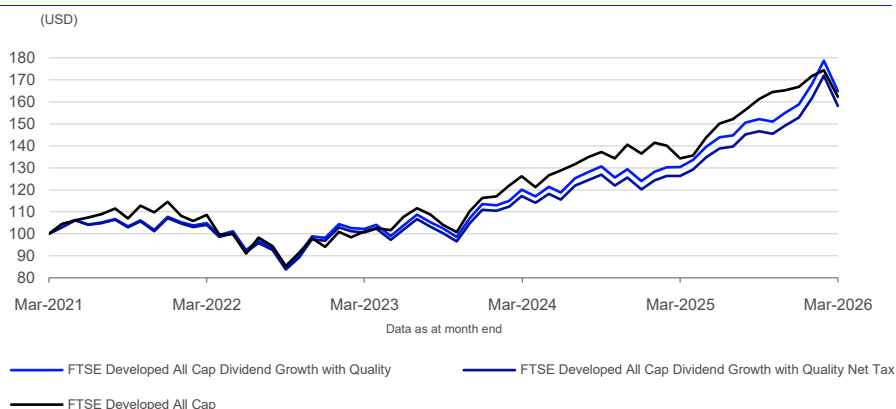


FTSE Developed All Cap Dividend Growth with Quality Index
